

Hi Dominic,

Thanks for taking the time to meet with Terry and I today – it was great that you could visit and familiarise yourself with our office in Alexandria.

I confirm the outcomes of today's agenda:

**2010-11 Biennial Return** – you advised that the information we requested would be forthcoming within the next week or so, to enable us to incorporate key findings from the Return into the next edition of our member magazine Action Packed, due late March;

**EVAT trial progress** – you advised that no applications has been received as yet, and that the Newcastle LGA would be added to the trial. Furthermore, you indicated that OLGR may be able to provide LSA NSW with regular (i.e. bi-monthly) updates on the progress of the EVAT, so as to assist us in our member communications;

OLGR's recent compliance activity re: underage sales & secondary supply – you agreed to follow up with Paul Newson in relation to sourcing specific information about the activity, which can be shared with LSA NSW;

**Liquor Promotion Guidelines** – you advised that it is OLGR's intention to finalise the new Guidelines by the end of March, with a view to launching (method TBC) shortly thereafter. LSA NSW will provide its final feedback to your revised draft within the next week, once we receive feedback from our key stakeholders.

Online Liquor Retailing – you have agreed to come back to myself with your feedback in response to my email to yourself, Cathrine, Lindsay and Paul dated 23<sup>rd</sup> January 2013. Furthermore, you agreed to follow up with your colleagues so as to coordinate their respective responses;

**OLGR database** – this was a late addition to the agenda, and you clarified my query in relation to the format the database is provided. Furthermore, as requested please find attached a soft copy of the recent letter to Elizabeth Tydd re: the OLGR database form. We do feel that the wording in the form could be 'tightened up' somewhat, so as to better protect the integrity of the information.
